Terms and Conditions

- 1. Owner of the Dam agrees to pay \$500.00 (Due at time of first tie) Non-refundable.
- 2. One live birth constitutes a litter.
- 3. The owner of the stud has no control over the litter's size as adults, future temperaments and habits, or appearance.
- 4. The owner of the Stud is not responsible for any of the following conditions that may occur within the litter as they are cosmetic and not life threatening and are also common among the Shih Tau breed: Umbilical Hernias, Pinched Nostrils, Open Fontanels, Cherry Eye, and Misaligned Teeth.
- 5. The owner of the Stud is not responsible for any deformities that may occur with the litter.
- 6. Should the Dam fail to produce a litter, a repeat breeding at the Dam's next heat will be repeated free of charge.
- 7. Should the Dam produce a dead litter, a repeat breeding at the Dam's next heat will be repeated free of charge one time.
- 8. The owner of the Dam agrees to confine the Dam after the mating to ensure that she has no contact with any other male.
- 9. Dams' owners must be willing and able to provide proper care for the litter.
- 10. The dams' owner agrees that no puppies from resultant litter will be sold to pet stores or other wholesale outlets.

- 11. The dam must be in good health and condition at the time of breeding and must be free of hereditary defects, parasites, or infections.
- 12. The dam must be of good conformation and temperament and be physically suitable for breeding to the selected male.
- 13. A recent negative culture and Brucellosis test are required. A culture or veterinary examination is required at the owner's expense.
- 14. A stud dog provides a valuable service and the dam's owner shall be liable for any loss of future service due to the dam's owner concealment of health problems.

Prior to the execution of this or any other contract, all parties are advised to seek the assistance of competent legal counsel.

This contract shall be governed by the laws of the state of Tennessee to the exclusion of any other forum and constitutes the entire agreement between the parties.
